INTERLOCAL AGREEMENT BETWEEN TOWN OF ANTHONY AND ANTHONY INDEPENDENT SCHOOL DISTRICT

This Interlocal Agreement (this "Agreement") is made between the TOWN OF ANTHONY, TEXAS ("Town") and ANTHONY INDEPENDENT SCHOOL DISTRICT ("School District") as of 20th day of January 2023.

1. Recitals.

WHEREAS, the Town maintains a park located at 102 Richard White Road in Anthony, Texas (the "Park"); and

WHEREAS, the park includes a baseball field for use of the public; and

WHEREAS, the Town and School District agree that the School District may use the baseball field for its high school and middle school baseball program during the School District's baseball season; and

WHEREAS, the School District and Town are authorized to enter into interlocal agreement pursuant to Section 791.001, ct seq.1 Texas Government Code; and

WHEREAS, the arrangements provided through this Agreement will afford efficiency and cost savings to the Town and School District and will benefit their respective students, residents and taxpayers;

NOW THEREFORE, for and in consideration of the recitals, agreements and covenants set forth herein, the parties hereby agree as follows:

- 2. <u>Use of Baseball Field.</u> The School District is hereby authorized to use the baseball field at 102 Richard White during its regular baseball season for practices and games. The School District shall have the first and exclusive right to the baseball field for the dates and times that it conducts practices and games for the high school and middle school baseball teams. The School District shall provide to the Town a copy of its practice schedules and game schedules. The Town shall make the baseball field exclusively available to the School District at those dates and times. The Park may be used by the public at other dates and times that do not interfere with the School District's use.
- 3. <u>Use by Town.</u> The Town may use the baseball field at such times other than the agreed scheduled uses by the School District. It is contemplated that the Town will use the baseball field for recreational programs during the summer and other times during the school year.
- 4. <u>Maintenance and Repair of Baseball Field.</u> The Town shall maintain the baseball field at its sole cost and expense, including planting, water, maintenance and repair except for the obligations and duties of the School District set forth herein.

- 5. <u>Duties and Responsibilities of School District</u>. The School District shall, at its sole cost and expense, maintain the field in good condition and repair during its periods of use, shall be responsible for painting or marking of the field for its games, and shall provide all equipment necessary for the conduct of its practices and games. The School District shall also be responsible for paying the portion of the total electric bill attributed to metered electricity usage during its periods of use of the baseball field. The School District shall be responsible for manually turning the baseball field lights on and off at each event and for logging metered usage.
- 6. <u>Term.</u> The initial ter of this Interlocal Agreement shall be one (1) year commencing on January 20, 2023 and concluding on January 20, 2024 and shall continue on a year to year basis thereafter unless either party terminates this Agreement in writing by giving thirty (30) days written notice to the other party.
- 7. <u>Liability</u>. This Agreement is not intended to alter or reallocate any defense or immunity presently authorized by law, or to create or transfer any liability arising under the law. The School District and the Town shall each bear any liability or risk of loss for claims arising from the acts or omissions of their respective employees and agents. Each party agrees that it shall be responsible for its own officers, agents and employees who are performing duties under this Agreement, and neither shall be liable or responsible for the acts or omissions of the other's officers, agents or employees.
- 8. Premises Liability. The Town shall maintain general liability insurance covering any claims arising from premises liability for use of the baseball field and include the School District as an additional insured.
- 9. Governmental Immunity. The School District and the Town reserve and do not waive their respective rights of governmental immunity from litigation and liability, and do not waive their rights under the Texas Torts Claims Act. No provision of this Agreement that imposes an obligation or restriction on either party not permitted by applicable law shall be enforceable.

10. Miscellaneous.

- A. Entire Agreement. This Agreement constitutes the entire agreement of the parties and supercedes all prior agreements or understandings, whether written or oral.
- B. Notices. Any notice authorized or required to be given under this Agreement shall be delivered or sent to the following addresses:

- C. Compliance with Law and Regulations. The parties agree to comply with all applicable local, state and federal laws, ordinances, regulations and orders.
- D. Governing Law. This Agreement shall be governed in all respects in accordance with the laws of the State of Texas, and shall be enforceable in El Paso County, Texas.
- E. Counterparts. This Agreement is being executed in multiple counterparts, each of which shall constitute an original and all of which together shall constitute but one and the same instrument.
