The Animal Welfare services department has branched out from the Sheriff Department. Mayor wanted to negotiate about including shelter fees as a fixed fee with the interlocal agreement. At the moment, the town gets billed separately for the impound fees. The Executive Director mentioned that the agency is working on setting up there own shelter fees and a shelter location so this agreement can be something that can be done in the near future. For now, the contract will remain for another three years at an annual fee of \$7,878.96.
